Protecting Your Privacy and Hearing Your Feedback

Life Without Barriers (LWB) understands how important it is for all of us to have information about us kept secure. LWB has a privacy policy that describes:

- how we will use your information
- some reasons why information about you may be given to other organizations or individuals from time to time
- how you can find out what information we hold about you
- how to correct that information if it is wrong
- how you may complain if you think we have mismanaged any of your information
- how we will deal with that complaint.

Please note that we will not disclose any of your personal information without your consent unless we are authorised or required by law.

Collection of your personal information

In addition to the information you provide to us, we may also need information about you from medical professionals and other organisations so we can deliver support to you. We will only seek this information with your full consent.

Any personal information provided to us by you is protected under the *Privacy Act 1988*.

You can ask to see what personal information (if any) we hold about you at any time and can seek correction of that information if it is wrong.

If you do not provide all of the information we request from you:

- we may not be able to provide you with the supports you want or need
- delivery of your supports by LWB might be delayed

Use and disclosure of your personal information

We will use your personal information to:

- decide whether we can deliver you the supports you are seeking from us
- work with you to prepare and review your plan of NDIS funded supports, or that part of the plan you wish us to deliver
- support you in accessing supports that are outside the NDIS that you are seeking our assistance with
